Combing operation: Whereabouts of 110 criminals checked, 46 found missing

THE CRIME branch of Pune City Police conducted an extensive combing operation and checked the whereabouts of 110 history sheeters, including criminals on record for house break-ins.

A press release stated that as per instructions of Police Commissioner K Venkatesham, a team conducted the combing operation early on Saturday.

Of the 110 history sheeters checked by the Crime Branch, 25 were found to be in jail, eight were externed and one had died. Also, 30 history sheeters were found at the spot and their interrogation forms were recorded. Meanwhile, 47 history sheeters could not be traced during the combing operation, as stated in the press release.

During the combing operation, police also took action against hotels that were allegedly found open beyond the specified deadline. As many as 19 such offences were lodged against hotels in different parts of the city for operating till midnight without permissions.

One person was also arrested and 53 liquor bottles and Rs 10,420 was seized from the accused. During the operation, police also rescued a woman, who was allegedly being lured into a hotel in Katraj area.

THE CRIME Branch of Pune City Police on Sunday seized Fake Indian Currency Notes (FICN) to the tune of Rs 64,500 from two men.

The Police are trying to find

out from where the money originated.

Crime Branch officers received a tip-off about two men coming to Pune to deliver FICN.

The police laid a trap and intercepted a car in which two men were travelling.

On searching the car, they recovered FICN to the tune of Rs

64,500. The accused, identified as Shubham Kshirsagar (24) and Rahul Vachkal (20), both from Satara, were arrested.

Officials said they have recovered three notes of Rs 2,000 denomination, 80 notes of Rs 500 denomination, 92 notes of Rs 200 denomination and one Rs 100 note.

Alcon site engineer held for Kondhwa wall collapse

Pune: The Kondhwa police on Thursday night arrested the site engineer the Alcon Landmarks realty firm had hirodfor supervising the construction of the Alcon Stylus society's retaining wall, which caved in following incossant rain on June 29.

The site engineer, Rajaram Maruti Kale (32), is the third person arressed in the case. Judicial magistrate first class RT Ingle at the Cantonment court on Friday ordered Kale's remand in police custody dill August 2.

Alcon partners Vivek Sunii Agarwal and his brother; Vipul, were arrested earlier. They are currently in judicial custody and lodged in Verawada tall.

The arrested site engineer, Kale, is the 11th person named in the FIR. The police also added the name of the architect of the "Royal Exortica" project on which the humments of the deceased people were built to the FIR. But he has not been arrested yet.

Fifteen workers were killed and two others were injured when the debris of the Alcon Stylus' wallfell on their huss on the adjacent construction site "Royal Exotica", being developed by the Kanchan Group.

The Kondhwa police initially named 10 people—five Alcon partners, four Kanchan Group partners and a structural designer hired by Alcon in 2014 for the repair and strengthening of the wall — in the FIR for culpable homicide not amounting to murder, common intention and offences under the Maharashtra Fiat Ownership Acc (MOFA).

Inspector Mahadeo Kumbhar, the Kondhwa police's Investigating officer, told TOI on Priday, "Kale's name figured during our investigation as the

Biker arrested for abusing woman cop, aide booked

Pune: The Samarth police on Wednesday arrested a man and booked a woman for attacking as well as abusing a policewoman for taking a photograph of their motorcycle that had halted on the zebra crossing line at Banerjee Chowk.

The arrested man is Sagar Jhambulkar (27), a resident of Kasarwadi Road.

The police have served a notice to Jhambulkar's friend under section 141 of the Code of Criminal Procedure, directing her to appear before the investigation officer and extend cooperation in the investigation on Thursday. However, the woman failed to turn up at the police station.

Senior inspector Balkrishna Kadam, in-charge of the Samarth police station, said, "The policewoman was taking action against traffic violators at Banerjee Chowk when she spotted the man (Jhambulkar) riding on a motorcycle that had stopped on the zebra crossing. The policewoman clicked a photograph of the motorcycle and posted it on the Satark Punekar app to take further action against the man."

clist drove ahead after the traffic signal turned green but he suddenly took a U-turn and returned to where the policewoman was discharging her duty. The woman riding pillion argued with the policewoman over clicking the photograph without seeking their consent and hurled abuses at her in a foul language."

"The policewoman explained why she was clicking the photo and posting it on the app but the woman was in no mood to listen. The woman suddenly attacked her, snatched her smartphone and threw it aside after the dispute between them became heated," he said.

"The bike rider also abused the policewoman using flithy language. A beat marshal brought them to the police station to take action. The rider, who works as a medical representative, was arrested and his friend was served a notice," Kadam stated.

The incident happened in the presence of two eyewitnesses. The woman later tendered an apology to the policewoman. The cop has lodged an FIR against the duo for obstructing her from discharging her duty and voluntarily causing grievous hurt, among other sections of the Indian Penal Code.

Meanwhile, Jhambulkar was remanded to magisterial custody for 14 days and sent to the Yerawada central tail.

Music teacher arrested in minor student rape case

Pune: A music teacher (44) was arrested on Monday on the charge of raping his 17-year-old student for three months and threatening to kill her elder brother, besides defaming her on social media, if she told anyone about it.

The rape survivor, however, mustered courage on Monday and narrated her ordeal to her parents, following which an FIR was lodged with the Sahakarnagar police, leading to the arrest of the teacher.

"The teacher has been arrested under sections 376 (rape), 506 (criminal intimidation) of the Indian Penal Code and the relevant sections of the Protection of Children from Sexual Offences (POCSO) Act," an officer from the Sahakarnagar police said.

The rape survivor had started learning music from the suspect in April. "The suspect used to teach her at his house in Dhankawdi. The girl has stated in her complaint that the suspect used to force her inside his bedroom and used to rape her by tying her limbs. Whenever she resisted, the teacher used to threaten to slit her throat with a knife," the

Engineer forced to kiss woman, videos & photos forwarded

Pune: The Sangvi police on Monday registered an offence against four unidentified persons, including a woman, for abducting a mechanical engineer in a car and forcing him to kiss the woman inside the moving vehicle, recording videos, clicking photographs and forwarding it to an unknown person.

The incident happened on Friday morning near Aundh Chest Hospital in Sangvi. The suspect abandoned the engineer at Baner after two hours and fled. He approached the Sangvi police and lodged an FIR on Monday.

The police have registered the offence under section 363 (kidnapping), 504 (intentional insult with intent to provoke breach of the peace), 506 (criminal intimidation) of the Indian Penal Code and the relevant sections of the Information and Technology Act.

Senior inspector of the Sangvi police Prabhakar Shinde told **TOI**, "The engineer did not know them. We have started collecting CCTV footage of the route between Sangvi and Baner to ascertain the identity of the suspects."

The complainant works at a private company in Hadapsar. On Friday around 8.30 am he was on his way to work when a white hatchback blocked his way near the hospital. There were three men and a woman inside. "The suspects forced him inside and drove towards Baner. They then threatened to kill the engineer and told him to kiss the woman. Herefused but they forced him and took photographs and videos and sent it to someone," Shinde said.

After driving around for two hours, they abandoned the engineer near a car showroom in Baner and drove away. TNN

The officer said the suspect had also threatened to kill her brother and defame her on social media if she revealed anything to her parents. "Our probe is on," the officer said.

The girl alleged that the suspect hacked into her social media accounts on May 30 and gained access to her photographs. The hacker then started sending the girl obscene messages and demanded that she send her nude photographs. The suspect did not specify whether s/he was a man or a woman, the FIR stated.

When the girl refused multiple such demands, the suspect smeared her reputation. "On May 31, the suspect uploaded her photographs on a social media platform and said the girl was a call girl. The suspect continued to harass her," police said.

Shaken, the girl submitted a written complaint to the cybercrime police, who referred it to the Mundhwa police.

A case has been registered under IPC sections 354 (d) and 500, as well as the IT Act.

Senior inspector Sampat Bhosale said they believe the suspect is not from Maharashtra.

Commuters had a harrowing experience on Friday night due to traffic jams in Khadki, on old Pune-Mumbai Highway and Elphinstone Road.

The traffic jams, which began at around 7.30 pm and lasted till around midnight, were caused after an empty goods train halted while travelling from the 512 Army Base Workshop towards the Khadki railway station.

Many commuters had to stand in the rain, as the jams stretched from Nashik Phata to Wakadewadi as well as on the Khadki Bazaar road.

Many people shared photos of the traffic jams on social media and also shared their experiences. The traffic jams were compounded as a PMPML bus broke down near the railway station.

While the authorities started the blame game, the traffic branch of the city police has decided to issue a notice to the Khadki Railway station master for allowing the train to stop, knowing there was heavy traffic on Fiday.

People's Woes

Daily commuters were on their way home after office hours. "Generally, a traf-fic jam is expected during the peak hours on the old Mumbai-Pune highway, On Friday, there was a massive traffic iam due to the heavy rainfall, and the bro-ken-down PMPML bus on the highway added to the woes," said Pranab Chatterjee, a techie working in an IT company in Wakadewadi. "I was stranded for at least an hour near the All Saint's Church Chowk, after which I somehow managed to turn towards Khadki Market, where the traffic came to a halt. I took a U-turn and took a detour from Aundh road to Pimpri," he said.

Amol Deshpande of Pimpri Chinchwad Citizen's Forum was stuck for four hours near Harris Bridge, Dapodi. Worst traffic jams were witnessed at Wakadewadi, Khadki, Bopodi and Dapodi. "I took a PMPML bus at 8.30 pm and reached Harris The traffic jams, which began at around 7.30 pm and lasted till around midnight, were caused after an empty goods train halted while travelling from the 512 Army Base Workshop towards the Khadki railway station.

Bridge at 10.30 pm. The 4-km travel took 2 hours. A bus was broken down and behird it, two buses and 7-8 vehirles were stuck. I reached Nigdi at 11.30 pm," he said.

What caused traffic jams. According to the traffic branch officials, tanks were being taken to Army Base Workshop for repair on July 17, but there was no jam as Railways and Army had informed about it in advance and vehicle movement was not disturbed as cops were

there to manage traffic Police Inspector Sangee ta Patil, in-charge of Khad-ki traffic division, said, "On Friday, the empty goods train was returning but we were not informed about it. During peak hours, there is always heavy traffic. It was Friday, so there was heavy vehicle movement than usual. After the train stopped mid-way blocking the traffic on highway and Elphinstone Road, we were on duty till midnight. She further added, "I will write to the Khadki Railway station master about the timing of the train move ment and ask them to intimate us in advance to avoid inconveniences to commuters. I have also spoken to Army officials."

When contacted, Manoj Jhawar, spokesperson of Pune Railway division, told Sakal Times, "On Friday, the 31 empty wagons were being brought back to the Khadki station. Traffic was stopped for 20 minutes at the highway side and 40 minutes near the Kirloskar factory on Elphinstone road. The train movement was slow, The Railways take precautions every time when the train passes through, as there are encroachments near the tracks and people cross the railway lines. We always re-quest citizens to cooperate with the railways."

uneis abudding hubfor IT and has also been dubbed as the next silicon valley of India. But with an inflow of IT professionals in the city, even the problems faced are becoming unique. An example of this is an incident which took place in Manjari when a drunk 21-year-old slashed his roommates with a knife and assaulted a girl.

Six friends—three girls and three boys—had recently moved into a 3BHK flat in Manjari. The next day they decided to have a party in the house and consumed liquor. While this party was about to die, an altercation between the boys resulted in one of the friends to fly into a rage and slash his friends with a knife.

The incident happened on July 26 morning at 5.30 am at Atharva Heights Society on the Mundhwa-Manjari Road. The accused has been identified as Yash Gopal Ahir (20) and has been arrested by Hadapsar police. According to the FIR, of the six friends, two are working in an IT company in Kharadi while the rest were looking for jobs. Sahil Satish Patel (21), filed a complaint with Hadapsar police station after which the ac-

cused was arrested and produced in court, which remanded him in police custody for five days.

According to the police, these six friends had come to the city from various areas in the country and had decided to stay together in Manjari.

They had shifted in the newly rented apartment just two days before the incident. They had decided to celebrate this new chapter on Friday night and had consumed alcohol.

The accused allegedly had entered the room of one of the drunken girls where she was crying and tried consoling her. Hearing her cries, the rest of the friends came looking and doubted that the accused did something to her. The two boys living in the house confronted Ahir, who denied doing anything to the girl.

The minor misunderstanding escalated when the accused picked up a knife and attacked Patel and Anivesh Deshraj Verma (20). Another girl who was trying to sort out the fight was then assaulted by Ahir. Scared, the girl ran downstairs and called the police control room for help. Patel

and Verma have been injured in the attack.

Talking to Mirror, Verma said, "We are six friends staying together and had just moved into the new flat. We were partying late into the night that day and Yash was misbehaving withour roommate. So we argued with him over the issue but he got so angered that he attacked us with a knife."

"One girl from our group is working and just came back home after finishing her shift. We all were having breakfast when Yashentered another girl's room. We heard her shouting and when weentered the room wesaw her crying. When we asked Yash why she was crying, he got angry that we doubted him and assaulted me and others," added Verma.

Assistant inspector Prasad Lonare from Hadapsar police station told Mirror, "The six know each other from the last three months. The accused had got them together and planned to stay in the rented flat. They had a dispute when they were partying late in the night and the accused attacked the others in a fit of rage." Police said Ahirhasbeenbooked under sections 326 (Voluntarily causing hurt by dangerous weapons), 323 (punishment for voluntarily causing hurt) and 504 (intentional insult with intent to provoke breach of the peace) of the Indian Penal Code.

Cyber cell helps a company recover funds from Mexico

city-based chemical company stood to lose Rs 3.41 crore they'd paid for procuring a consignment from Mexico, when its email interactions were interceded by hackers. The intervention by the cyber police helped recovered the money from a Mexican bank.

Called "man in the middle attack" in cybercrime parlance, the online fraud occurred last month, when the Indian company was trying to place an order for some material. The company —SRC Chemical Pvt Ltd made two transactions — one of \$166,276.25 on June 14, this year and second of \$329,405.85 on June 18 to an account with Banco Mercantil del Norte. On the Indian side the money was transacted through HDFC Bank. It was pursuant to doing this that the company officials realised that the intended beneficiary and the account holder were not the same.

They quickly filed a complaint with the cybercrime cell of Shivajinagar police station on June 20. "We contacted the Mexican bank as the mediator in the transaction. In a written communication we instructed that they freeze the Rs 3.41 crore," informed PI Jayram Paigude. The

quick realisation and intervention helped to save the company's money, he added. "Most often the victim fails to notice the email source and this gives the fraudulent beneciary the opportunity to divert the money to other bank accounts, making it impossible to trace the transaction amount. Professionals should cross-check the beneficiary account number with a phone call when making financial deals," he pointed out.

In this case the money was routed through the Society for Worldwide Interbank Financial Telecommunication transaction involving JP Morgan. On July 11, the beneficiary bank wrote back informing that they had blocked the money from being moved out of the indicted account and it would be reverted to the original source.

SRC Chemical is not the first company the cyber cell has helped recover their money. Earlier it had managed to get refund of Rs 4.5 crore for another company defrauded in a similar fashion. Based on the complaints they have been handling the cybercrime police urged that companies should transfer big money only after calling the beneficiaries to verify the account details. The firms also need to put in place strong security systems and fire walls to prevent the hacking of emails and other online processes. Once they realise they've been hacked or defrauded they should not delay in bring the police in.

Two held with fake currency notes in city
